## School Board Meeting May 4, 2015

The regular meeting of the Redbank Valley School Board was held, Tuesday May 4, 2015, 7:00 P.M., Redbank Valley High School Library. The following members were in attendance: Adam Barrett, Dee Bell, Wendy Heeter, Tina Kennemuth, Ann Kopnitsky, Donald Nair, Shirley Pastor and Chad Shaffer. Brian Dougherty was absent.

The regular school board meeting was called to order by President Chad Shaffer at 7:00 p.m.

A motion was made Tina Kennemuth seconded by Donald Nair to approve the Regular meeting minutes on April 7, 2015 and the Work Session Meeting minutes on April 7, 2015. It is to be noted that an Executive Session was held on April 22, 2015. Motion Carried Unanimously

Mr. Shaffer then asked if the public had a concern to address. Dr. Rosasti (from Clarion University) wished to address the school board. She was denied the opportunity due to school board policy whereas she was not a resident of the school district. Judy Rupp a parent addressed the school board as to second grade enrollment and staff concerns for 2015-16. Jessica Kirkpatrick a parent addressed the second grade staffing concerns.

The Student Representative report was unavailable.

The Primary /Director of Education report was presented in writing by Mrs. McCauley. Mrs. McCauley was absent from the meeting due to her attendance at the Federal Programs Conference.

The Intermediate Report was given by Mrs. Sue Ann Boyles. Mrs. Boyles informed the school board of the Elementary Concert held on April 30, 2015 as the students did a fabulous job at the concert and enjoyed the evening. Mrs. Boyles commented on the elementary reading competition held on April 9, 2015. The fourth grade team placed first in the region at the competition.

The Secondary Report was presented by Mrs. Sue Ann Boyles. Mrs. Boyles informed the school board that there will be 78 graduates. Mrs. Boyles commented that the annual Mission Transition for 6<sup>th</sup> graders will be held May 11<sup>th</sup>. This annual event gives 6<sup>th</sup> graders a days' experience at the high school level accompanied with a buddy 7<sup>th</sup> grader.

The Maintenance Report was presented by Mr. Sayers. Mr. Sayers reported about Cintas's proposal for cleaning supplies.

The Superintendent Report was presented by Mr. Drzewiecki. Mr. Drzewiecki informed the school board that the new High School Principal, Amy Rupp will be introduced on Friday, May 8<sup>th</sup> to the High School staff. She will meet and address the staff. Mr. Drzewiecki commented on the Basic Education Funding in which that exceeds the 1.9% Act 1 index. Districts

are required to invest in one of 13 evidenced based strategies improving student learning. The proposal exceeding the index for Redbank Valley will be an offset under our full-day kindergarten program as we have in under the Accountability Block Grant funding received in prior years.

The CCAVTS Report was presented by Dee Bell. Mr. Bell commented that the CCAVTS has purchased a Diesel Engine Training System for the next school year. A CCAVTS agenda was provided in the school board member's packet.
