The Temporary President cast 8 votes for Chad Shaffer as President. Donald Nair announced that Chad Shaffer is elected President, Redbank Valley School Board.

Chad Shaffer asked for nominations for Vice President.

A motion was made by Donald Nair to nominate Bill Reddinger for Vice President of the Redbank Valley School Board.

A motion was made by Donald Nair, seconded by Dee Bell, that the nominations for Vice President be closed. Motion Carried Unanimously.

The Board President cast 8 votes for the position of Vice President. Chad Shaffer, President, announced that Bill Reddinger is elected Vice President, Redbank Valley School Board.

A motion was made by Donald Nair, seconded by Ann Kopnitsky, that the nominations for Legislative representative be closed. Motion Carried Unanimously.

The Board President cast 8 votes for Carrie Adams to be the Legislative Representative. Motion Carried Unanimously.

Chad Shaffer announced that two Career Center Representatives needed to be appointed and asked Bill Reddinger and Donald Nair if they would like to remain representatives.

Linda Ferringer volunteered and Bill Reddinger offered to stay on as Career Center Representatives.

A motion was made by Bill Reddinger, seconded by Dee Bell, that the nominations for Career Center Representatives be closed. Motion Carried Unanimously.

The Board President cast 8 votes for Bill Reddinger and Linda Ferringer to be the Career Center Representatives. Motion Carried Unanimously.

Dr. Shaffer asked Ann Kopnitsky if she would like to continue as Intermediate Unit Representative.
