

Special Board Meeting
August 12, 2020

A work session of the Redbank Valley School Board was held on Thursday, August 12, 2020 at 6:30 p.m. in the Redbank Valley High School Library. The following members were in attendance: Carrie Adams Dee Bell, Jason Barnett, Bill Reddinger, Linda Ferringer, Chad Shaffer, Ann Kopnitsky, and Don Nair. Absent Darren Bain.

The board meeting was called to order at 6:30 p.m. by Bill Reddinger, President.

Mr. Reddinger asked if there was any public concern: Matt Darr spoke on chemicals being used to clean in the district, would like listing. Mr. Jones has the sheets to inform public.

New Business:

A motion was made by Dee Bell seconded by Ann Kopnitsky to accept the Laura Heasley resignation effective immediately. Motion Carried Unanimously

A motion was made by Dee Bell seconded by Chad Shaffer to approve that the superintendent can accept resignations and have them ratified at the next official board meeting. Motion Carried Unanimously

A motion was made by Ann Kopnitsky seconded by Dee Bell to approve entering into agreement with AC Valley School to provide special education services for a Life Skills student. Motion Carried Unanimously.

Justin Karam discussed the reason for special education teachers needed at the primary. The requirements that the students need. Keeping students in the district to save money and not sending students to other districts. Life Skills for students at the high school.

A motion was made by Chad Shaffer seconded by Dee Bell to grant permission to the superintendent to repurpose CARES funding for the installation of a card swipe at the Primary Campus in the amount of **\$1,767.58**. Motion Failed Unanimously

A motion was made by Dee Bell seconded by Carrie Adams to approve the purchase of a sound system for the library to conduct board meetings at a cost of **\$4,600.00**. Motion Failed 6-1 Dee Yes

A motion was made by to approve the hiring of Madison Nugent as Head Cheerleading advisor at 90 points according to the CBA for a cost of **\$3,825.00** for a total cost of **\$3,933.92**. Failed for lack of a motion.

Discussion occurred about the actual need and budgeting required for this position.

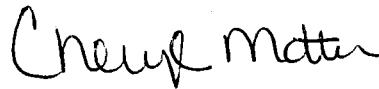
